CALL TO ORDER

Chairwoman Leon presided over the meeting and called the meeting to order at 6:01 P.M.

ROLL CALL

Roll call showed Chairwoman Lourdes M. Leon, Vice-Chairman Joseph C. Bodek, Commissioner James E. Baker Jr., Commissioner Michèle S. Delisfort, Commissioner Sergio Granados, Commissioner Bette Jane Kowalski, Commissioner Alexander Mirabella, Commissioner Kimberly Palmieri-Mouded, and Commissioner Rebecca Williams were present.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen Esq., and Clerk of the Board James E. Pellettiere.

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

PRESENTATIONS TO THE BOARD

A presentation was made by Ritesh Shah, of Ritesh Shah Charitable Pharmacy (RSCP), to the Board relative to the RSCP charitable efforts in increasing access to medications, immunizations, health education, and pharmacy services for uninsured and underserved patients to reduce clinical and social health inequities to Union County residents. The video presentation was followed by a resolution presentation by the Board to Ritesh Shah.

Chairwoman Leon introduced Ritesh Shah, of Ritesh Shah Charitable Pharmacy, a leader in local efforts to increase access to medications, immunizations and pharmacy services for uninsured and underserved patients throughout New Jersey, including Union County.

Ritesh Shah, of Ritesh Shah Charitable Pharmacy, recognized County Manager Oatman, Deputy County Manager Wagner, and Human Services Director Anderson and thanked the County of Union for facilitating this tremendous partnership. Mr. Shah noted that he was inspired by the passing of his younger sister to create a charitable pharmacy for patients who were financially unable to secure life-saving medications, adding that he and his wife, also a pharmacist, had devoted themselves to making a difference in the lives of those in need. He advised that in the last year alone, RSCP, had saved patients nearly \$230,000 by providing vital medications at no cost, noting 1,614 prescriptions filled and 908 refills dispensed. Additionally, he

noted that the pharmacy employed two volunteer pharmacists and currently served 58 patients. He added that this achievement was a reflection of RSCP and the County's commitment to increasing access to critical medications for underserved residents. He thanked the County for their partnership.

Chairwoman Leon thanked Ritesh Shah, adding that the County of Union and Board were proud to support his efforts.

Commissioner Granados thanked Ritesh Shah for the great partnership and lifesaving resources provided by RSCP.

Commissioner Granados asked Prosecutor Daniel to elaborate on this item.

Prosecutor Daniel advised that this item related to a 15-month renewal for a resource used by investigative personnel within the Prosecutor's Office to search cell phones and other electronic devices during confidential investigations. He added that this resource was of no cost to the County and was funded by monies received from forfeiture accounts related to illegal operations.

Deputy County Manager/Director Wagner advised that the 2025 Infrastructure and Municipal Aid Grant Program afforded municipalities within Union County an opportunity to apply for and receiving grant funding for various infrastructure projects including roadway improvements and security measures, among other improvements. She noted this was the ninth year the County was offering this grant opportunity and advised that the monies would be awarded at the next Commissioners meeting.

4. Authorizing the County Manager to award a contract obtained through advertised public bidding in accordance with the Local Public Contracts Law N.J.S.A. 40A:11-1 et seq, (BA#20-2025) to Johnston Communications, Springfield, NJ, for a period of twenty-four (24) months with an option to renew for 24 months to provide electronic network equipment, security and cabling to various County Departments in an amount not to exceed \$671,600.00. Commissioner Baker asked Director Taylor to elaborate on the CAP Bank. He also asked if this was done annually and if the monies rolled over.

Director Taylor advised that the CAP Bank was a financial management tool that many counties utilized to essentially bank the difference between the amount being raised in taxes in the current year's budget and the amount the County was allowed to raise statutorily, adding that the County was subject to the 1977 CAP. She further advised that the County was eligible to bank roughly \$14 million under the 1977 CAP and \$24 million under the 2010 CAP. She noted that in the last 10 years, the County had not had to utilize the any of its CAP bank. She once again noted that the CAP was merely a financial management tool that would allow the County to access it in the event of extraordinary circumstances. She added that this resolution was adopted annually once the County budget was introduced.

In partnership with law enforcement and the LEAD model, Director Anderson advised that this one-time funding to RWJBH – Trinitas Regional Medical Center would provide services to individuals suffering from substance misuse to ensure they receive the appropriate medical resources and enhance access to treatment prior to incarceration and or to avoid incarceration.

DEPARTMENT OF PARKS AND RECREATION

Deputy County Manager/Director Wagner represented the Department.

DEPARTMENT OF PUBLIC SAFETY

1. Authorizing the County Manager to enter into a contract with Spec Rescue International, Virginia Beach, Virginia, to provide exercise support and training to members of the Metro Urban Search and Rescue (MUSAR) Task Force from the Urban Area Security Initiative (UASI) Region, utilizing 2023 and 2024 UASI grants, from April 1, 2025 through December 31, 2025, in an amount not to exceed \$229,495.00. (No cost to County of Union) (Commissioner Alexander Mirabella)

Commissioner Mirabella asked Director Burke to elaborate on this item.

Director Burke noted that the County of Union administered the grant portion of the northern New Jersey Urban Area Security Initiative (UASI) for emergency fire services. He added that the Metro Urban Search and Rescue (MUSAR) task force provided specialized training on extractions and other operations outside the normal scope of traditional fire rescue. He advised that there were twelve agencies within the region to be trained to this level, including the Elizabeth Fire Department.

OFFICE OF THE COUNTY MANAGER

Edward T. Oatman, County Manager

County Manager Oatman addressed the public...

There has been a great deal of discussion and some misinformation about the purpose of these two resolutions. To be clear, the resolution authorizes the County to issue a request for proposal (RFP) to put the jail property up for potential sale. It does not approve any specific sale, nor does it finalize any decision. It simply opens the door to explore potential interest and assess the property value. This is the first step in a larger and longer process, one that includes public input, transparency, and multiple stages of review before any action is taken. As County Manager I have a fiduciary obligation to the residents of Union County. We have a responsibility to explore opportunities that could result in meaning property tax relief for everyone, potentially exceeding 100 Million dollars. At the same time we are committed to ensuring that any future use of the property reflects the values and needs of our community. To that end, the RFP will include clear limitations on how the property can be used, specifically, if any proposals are received by operators interested in continuing to use it as a correctional facility, we will, consistent with state law, restrict use to housing individuals involved in the criminal justice system exclusively, such as those facing criminal charges. Other types of use will not be permitted under the terms we set. We do not control who may submit a proposal, but we do control the process. Let me emphasize, this step does not bind us to any sale. It simply allows us to gather the information we need to make an informed decision with public transparency. We are hopefully that this RFP will attract a diverse range of bidders from a variety of industries, reflecting innovation, creativity, and investment potential that exists across our region. Additionally, we must take into account the cost of inaction. Demolishing the facility will cost at least \$50 million. Renovating it for any other purpose will cost more than \$100 million. These are substantial figures that would impact the County's long-term finances. This resolution is the responsible first step that will allow us to evaluate all the possibilities both financial and practical while upholding our obligation to act in the best interest of Union County's residents.
