THURSDAY, DECEMBER 1, 2022 AGENDA SETTING MEETING MINUTES

CALL TO ORDER

Chair Williams presided over the meeting and called the meeting to order at 6:00 P.M.

ROLL CALL

Roll call showed Chair Rebecca Williams, Vice Chair Christopher Hudak, Commissioner James E. Baker, Jr., Commissioner Sergio Granados, Commissioner Bette Jane Kowalski, Commissioner Lourdes M. Leon, Commissioner Alexander Mirabella, and Commissioner Kimberly Palmieri-Mouded were present, with Commissioner Angela R. Garretson absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen Esq., and Clerk of the Board James E. Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

APPROVAL OF COMMUNICATIONS

Chair Williams advised that the Communications would be approved later during the Regular Meeting.

OFFICE OF THE UNION COUNTY CLERK

Joanne Rajoppi, County Clerk

1. Amending Resolution Number 2022-503, a contract with Royal Printing Services, West New York, NJ, to provide additional printing services necessary by new legislation for the 2023 Primary Election, General Election, and Special Election, in the amount of not to exceed \$329,631.00 for a total contract amount not to exceed \$2,540,730.00. (Chair Rebecca Lynne Williams)

Commissioner Kowalski asked Clerk Rajoppi to elaborate on the election-related increases.

Clerk Rajoppi advised that this item would cover two special elections, including an upcoming Westfield School Election that had been rescheduled from November 2022 to

April 2023. She further advised that the second special election was still unknown, adding that both of these elections would cost approximately \$110,000, noting that those monies were reimbursable. Clerk Rajoppi added that the remaining increases were a result of changes in legislation that occurred earlier in the year. She advised that due to early-voting alone, her office was required to supply each of the 432 voting district with 30 emergency and provisional ballots as well as respective envelops for both the Primary and General Elections.

2. Authorizing the County Manager to enter into a contract with Enhanced Voting, LLC, Jacksonville, FL, for the purpose of providing printing of canvas reports and software maintenance in the process of preparing and conducting elections in 2023 and 2024 in the amount not to exceed \$24,550.00 for the period January 1, 2023 through December 31, 2023, and not to exceed \$24,550.00 for the period January 1, 2024 through December 31, 2024, for a total contract amount not to exceed \$49,100.00 (Chair Rebecca Lynne Williams)

OFFICE OF THE UNION COUNTY PROSECUTOR

William Daniel, Prosecutor

First Assistant Prosecutor James O. Tansey represented the Office.

First Assistant Prosecutor Tansey recognized Vice Chair Hudak during his final meeting as County Commissioner and wished him well on his new position as County Surrogate.

1. Authorizing the County Manager to enter into a contract with Prevention Links, Roselle, NJ for the Overdose Data to Action - Operation Helping Hand Federal program for the period of December 1, 2022 through August 31, 2023 in an amount not to exceed \$49,894.00. (Chair Rebecca Lynne Williams)

Commissioner Leon asked First Assistant Prosecutor Tansey to elaborate on this item.

First Assistant Prosecutor Tansey advised that this item related to a partnership between the County Prosecutor's Office and Prevention Links aimed at providing resources and treatment to people dealing with substance abuse issues as an alternative to imprisonment.

- 2. Amending Resolution Number 2022-393, to apply for and accept funding from the State of New Jersey, Department of Law and Public Safety, Office of the Attorney General, Edward Byrne Memorial Justice Assistance Grant (JAG) Program to support the Multi-Jurisdictional Gang, Gun, and Narcotics Task Forces, to reflect the Subaward number JAG-1-20TF-18. All other aspects of the prior Resolution remain the same. (Chair Rebecca Lynne Williams)
- 3. Authorizing the County Manager to enter into an agreement with Vigilant Solutions, LLC, of Livermore, CA for an Integrated Service Agreement Renewal in an amount not to exceed \$16,500.00. (Chair Rebecca Lynne Williams)
- 4. Authorizing the County Manager to apply for and accept funding from the State of New Jersey, Office of the Attorney General, Department of Law and Public Safety, Office of the Insurance Fraud Prosecutor in the amount of \$250,000.00 for the period of January 1, 2023 through December 31, 2023, to continue efforts of

insurance fraud investigation in Union County (Cycle 2023). (Chair Rebecca Lynne Williams)

5. Authorizing the County Manager to enter into a contract with Rosa Jaramillo, Belleville, NJ to serve as an Independent Contractor for the Union County Per Diem Advocates Program for the Union County Prosecutor's Office for the period of April 1, 2022 through September 23, 2022 in an amount not to exceed \$20,185.00. (Chair Rebecca Lynne Williams)

Commissioner Baker asked First Assistant Prosecutor Tansey to elaborate on this item.

First Assistant Prosecutor Tansey advised that this item related to a contract renewal for Rosa Jaramillo who serves as the Office's Sexual Assault Nurse Examiner (SANE) Coordinator as an independent contractor. He advised that due to a delay in the required paperwork, two weeks of her salary would be charged to the Office's operating account.

DEPARTMENT OF ADMINISTRATIVE SERVICES

Laura Scutari, Director

County Manager Edward T. Oatman represented the Department.

There were no questions or comments by the Board.

- 1. Authorizing the County Manager to sign any and all documents necessary to enter into a Collective Bargaining Agreement with HPAE-Local 5112-Nurses, effective January 1, 2022 through December 31, 2025. (Chair Rebecca Lynne Williams)
- 2. Authorizing the County Manager to sign any and all documents necessary to enter into a Collective Bargaining Agreement with Teamsters Local 469-Secondary Supervisors effective January 1, 2022 through December 31, 2025. (Chair Rebecca Lynne Williams)
- 3. Authorizing the County Manager to sign any and all documents necessary to enter into a Collective Bargaining Agreement with Council No. 8 effective January 1, 2021 through December 31, 2023. (Chair Rebecca Lynne Williams)

DEPARTMENT OF ECONOMIC DEVELOPMENT

Amy Crisp Wagner, Deputy County Manager/Director

1. Authorizing the County Manager to award a contract to the Union County Economic Development Corporation, Cranford, NJ, for the purpose of providing general economic development services to private businesses within the County of Union for the period of January 1, 2023 through December 31, 2023, in an amount not to exceed \$100,000.00. (Chair Rebecca Lynne Williams)

Commissioner Granados asked Deputy County Manager Wagner to elaborate on some of the services offered through the UCEDC.

Deputy County Manager Wagner advised that the County had two separate contracts with the vendor, one focused on economic development training that would provide assistance to Union County businesses relative to securing loans. She further advised that the vendor was currently managing 207 loan for local, county businesses in an amount of \$8.5 million. She added that the vendor had also organized 45 separate training sessions that served approximately 450 individuals from Union County. She also noted that the vendor had provided 900 mentoring hours to Union County businesses. She further advised that the second contract focused on procurement services, noting that businesses would receive guidance on how to apply for and secure contracts with federal government agencies. She advised that there were 45,000 bid opportunities provided, adding that over \$100,000,000 in contracts had been awarded that year. She noted that those monies contributed to the creation and or retention of 2,700 jobs in Union County.

- 2. Authorizing the County Manager to award a contract to the Union County Economic Development Corporation, Cranford, NJ, for the purpose of providing procurement training/technical assistance to private businesses within Union County for the period of January 1, 2023 through December 31, 2023, in an amount not to exceed \$125,000.00. (Chair Rebecca Lynne Williams)
- 3. Authorizing the County Manager to enter into a contract with We Are One New Jersey Inc., Trenton, NJ, to provide social and human services that educate, empower, and uplift working families under the We Are One New Jersey Project, for the period of January 1, 2023 through December 31, 2023 in an amount not to exceed \$245,000.00. (Chair Rebecca Lynne Williams)
- 4. Authorizing the County Manager to exercise the second and final option to extend the contract with Millennium Strategies, Morristown, NJ, to provide grant writing and procurement services to the County of Union for the period of January 1, 2023 through December 31, 2023, in the amount not to exceed \$98,000.00. (Chair Rebecca Lynne Williams)
- 5. Amending Resolution Number 2022-705, authorizing the County Manager to apply for and accept funding from the United States Department of Transit (US DOT) for the Safe Streets and Roads for All (SS4A) Grant Program for the development of an Action Plan, to reflect the County's application as a joint application with the County as the lead agency and the City of Elizabeth to develop a Comprehensive Safety Action Plan to prevent roadway fatalities and serious injuries. (Chair Rebecca Lynne Williams)

Commissioner Kowalski asked Deputy County Manager Wagner to elaborate on this item and asked how much money the County expected to receive from the grant program.

Deputy County Manager Wagner advised that the County had already applied for this federal grant opportunity through the US DOT, adding that this particular item was meant to consolidate the County's initial application with the application submitted separately by the City of Elizabeth for the same purpose. She further advised that this grant award would allow the County to conduct a holistic assessment of roads to determine safety and eventually develop a comprehensive action plan to prevent roadway fatalities and serious injuries resulting from these dangers. She added that she expected the joint application between the County and the City of Elizabeth to yield approximately \$1.1 million in grant funding.

6. Authorizing the County Manager to amend Resolution Number 2022-983, a contract with Dell Computer Corporation, Round Rock, TX, for the provision of netbackup

and essential maintenance, to reflect account changes only. (All other terms and conditions remain the same.) (Chair Rebecca Lynne Williams)

DEPARTMENT OF ENGINEERING, PUBLIC WORKS & FACILITIES MANAGEMENTJoseph Graziano, Director

County Engineer Ricardo S. Matias represented the Department.

- 1. Approving a pre-qualified list of firms for the provision of General Engineering Services for the period of January 1, 2023 through December 31, 2023. (Commissioner Lourdes M. Leon)
- 2. Approving a pre-qualified list of firms for the provision of Architectural Services for the period of January 1, 2023 through December 31, 2023. (Commissioner Lourdes M. Leon)
- 3. Approving a pre-qualified list of firms for the provision of Construction Management Services for the period of January 1, 2023 through December 31, 2023 (Commissioner Lourdes M. Leon)
- 4. Concurring with the City of Rahway's Ordinance #0-45-22 passed on November 9, 2022 amending Chapter 401-26 of the Code of the City of Rahway loading zones from the apex of West Grand Avenue on the eastside of the street traveling north a distance of 308 feet and extending 46 feet north. (Commissioner Lourdes M. Leon)
- 5. Concurring with the Borough of Roselle Park's Resolution Number 276-22 authorizing an agreement with New Jersey Transit Corporation for two (2) bus shelters in the Faitoute Avenue Corridor (County Road 617). (Commissioner Lourdes M. Leon)
- 6. Amending Resolution Number 2020-603, a contract awarded through advertised public bidding (BA# 17-2020) in accordance with the Local Public Contracts Law, N,J.S.A. 40A:11-1 et seq., to T.R. Weniger, Inc of Piscataway, New Jersey, approving Change Order Number 1 (final) for the East Hazelwood Avenue Bridge, City of Rahway, County of Union, New Jersey. This change order will increase the original contract amount by \$73,972.26 for a new contract amount not to exceed \$584,332.26. (Union County Engineering Project Number 2021-021) subject to the approval of the New Jersey Department of Transportation. (Commissioner Lourdes M. Leon)

Vice Chair Hudak asked County Engineer Matias to elaborate on the change order. He also asked about the time-frame relative to the completion of the project.

County Engineer Matias advised that this item related to scour protection for the cited bridge-improvement project to mitigate soil erosion around the foundation of the bridge. He further advised that unsuitable soils had been identified at the location which required additional work to be done, hence the change order. County Engineer Matias confirmed that the project was completed and this would be the final change order.

DEPARTMENT OF HUMAN SERVICES

Debbie-Ann Anderson, Director

1. Authorizing the County Manager to institute the Countywide Code Blue Emergency Shelter Initiative to provide emergency shelter during emergency sheltering situations including days that qualify under the State of New Jersey's Code Blue law by the hotels, motels and shelters listed for the period of January 1, 2023 through December 31, 2023, in an amount not to exceed \$350,000.00. (Commissioner Sergio Granados)

Commissioner Mirabella asked for additional information relative to how the Code Blue Emergency Shelter Initiative was progressing this year. He also asked how the requested funding for 2023 compared to funding received for 2022.

Director Anderson advised that the County had already had approximately six Code Blue Emergency Shelter nights, adding that the initiative was activated once temperatures fell below 32 degrees. She added that through this initiative residents would be provided with shelter in the form of a warming center and or hotel/motel shelter accommodations as available. She further advised that Union County was seeing an uptick in homelessness and thanked the Board for their continued support in this area. Director Anderson advised that there was no change to the budgeted amount between 2022 and 2023.

Commissioner Baker asked for additional information about securing accommodations for larger families and inquired about the challenges that often arise from such sheltering needs.

Director Anderson advised that it was often difficult to place larger families in shelter-based facilities, noting that the County also secured in-county and out-of-county hotel/motel sheltering options to provide better accommodations for these larger families.

- 2. Authorizing the County Manager to award a contract to the United Way of Greater Union County to provide services under the 2023 Union County Family Support and Prevention (FSP) Program for the initial period of January 1, 2023 through June 30, 2023, with applicable extensions, in the total amount not to exceed \$125,000; and furthermore, requesting authorization to permit a one-time advance payment of up to one month of the award amount for the agency to carry out the program activities. (Commissioner Sergio Granados)
- 3. Authorizing the County Manager to award renewal subcontracts to various agencies under the 2023 Community Service Block Grant (CSBG) Spending Plan for the period of January 1, 2023 to December 31, 2023, in the amount not to exceed \$662,625.00; further authorizing the transfer of funds among awarded agencies during the contract period should service needs change. (Commissioner Sergio Granados)

Chair Williams asked Director Anderson to elaborate on this item.

Director Anderson advised that the CSBG Spending Plan focused on providing employment services as well as other emergency resources including case management, shelter services, and referral services among others. She added that this funding was reserved for individuals below the 200% poverty threshold. She noted that monies were channeled to the County's non-profit partners to provide the cited services and resources to qualifying residents.

- 4. Authorizing the County Manager to award renewal subcontracts under the 2023 Social Services for the Homeless (SSH) spending plan, for the purpose of providing emergency services and homeless prevention to residents of Union County in the amount not to exceed \$973,400.00 for the period of January 1, 2023 to December 31, 2023; further authorizing the transfer funds among the awarded agencies during the contract period should service needs change and/or if any of the listed agencies fail to meet contractual obligations. (Commissioner Sergio Granados)
- 5. Amending Resolution Number 2022-539, authorizing the 2020-2022 HEARTH Emergency Solutions-CARES Act (HESC) Spending Plan, to reflect a six (6) month grant extension for a new grant period through June 30, 2023. (Commissioner Sergio Granados)
- 6. Approving Medical Practitioners authorized to provide services to Cornerstone Behavioral Health Hospital of Union County for the period of January 1, 2023 through December 31, 2023. (Chair Rebecca Lynne Williams)
- 7. Authorizing the County Manager to enter into a lease agreement between the County of Union and Immaculate Conception Church, Elizabeth, NJ for the rental of 85 parking spaces at \$85.00 per parking space per month for the period of January 1, 2023 through December 31, 2023 in an amount not to exceed \$7,225.00 per month for a total annual amount not to exceed \$86,700.00. (Commissioner Sergio Granados)
- 8. Amending Resolution Number 2022-76, a contract with Frank M. Gargiulo & Son, Inc. dba Gargiulo Produce, Hillside, NJ, for the purpose of providing food for the Union County COVID-19 Emergency Food Distribution events for the period of January 1, 2022 through December 31, 2022, to reflect an increase in funding in an amount not to exceed \$75,000.00, for a new total amount not to exceed \$1,375,000.00. (Commissioner Sergio Granados)

Commissioner Palmieri-Mouded asked Director Anderson about the number of residents being served at the COVID-19 Emergency Food Distribution Drives.

Director Anderson advised that in 2022, the County had organized 18 food-distribution drives that impacted approximately 58,000 individuals in Union County. She noted that the County was able to use American Rescue Plan Dollars to off-set the food insecurity still plaguing many County residents. She further advised that in May 2020, the County organized its first emergency food distribution drive, adding that a total of 93 food-drives had been done since then, serving over 300,000 Union County residents. She confirmed that residents were required to show a proof-of-address prior to receiving their food parcel, adding that records of recipients were documented as required by federal spending regulations.

9. Amending Resolution Number 2022-75, a contract with Village Super Market, Inc, dba ShopRite of Union, Springfield, NJ, for the purpose of providing food for the Union County COVID-19 Emergency Food Distribution events for the period of January 1, 2022 through December 31, 2022, to reflect an increase in funding in an amount not to exceed \$75,000.00, for a new total amount not to exceed \$1,875,000.00. (Commissioner Sergio Granados)

DEPARTMENT OF PUBLIC SAFETY

Andrew Moran, Director

1. Authorizing the County Manager to enter into an agreement to authorize approval for participation in the Defense Logistics Agency, Law Enforcement Support Office (LESO), 1033 Program to enable Union County Police Department to request and acquire excess Department of Defense Equipment from January 1, 2023 through December 31, 2023. (Commissioner Kimberly Palmieri-Mouded)

Chair Williams inquired about the cited equipment.

Director Moran advised that this item related to a government surplus program managed by the U.S. military, adding that Union County had been a participant in this program for many years and had acquired a wide variety of equipment through the resource, including vehicles, generators, IT equipment, and tents among other items. He confirmed that the County did not seek to acquire non-lethal, non-tactical items.

2. Authorizing the County Manager to enter into a contract with Spec Rescue International, Virginia Beach, VA, to provide Tactical Forcible Entry Training to members of the Metro Urban Search and Rescue (MUSAR) Task Force from the Urban Area Security Initiative (UASI) Region, through the 2019 UASI grant, in an amount not to exceed \$7,950.00. (Commissioner Kimberly Palmieri-Mouded)

Vice Chair Hudak inquired about the 2019 UASI grant cited and asked about potential delays and disruptions to funding as a result of the COVID-19 pandemic.

Director Moran advised that the UASI grants were customarily awarded for a three-year period. He noted that under certain circumstances the County could apply for additional funding and or repurpose remaining funding for additional projects and training. He further advised that this particular item related to a new program focused on tactical, forcible entry. As a result of the COVID-19 pandemic, Director Moran confirmed that mass training exercises were suspended as were active-training drills and bleeding-control classes that were customarily held in person. He confirmed that the Department was working to ensure funding was used in the allotted time-frame and applied to the necessary training exercises.

OFFICE OF THE COUNTY COUNSEL

Bruce H. Bergen, County Counsel

There were no questions or comments by the Board.

1. Amending Resolution Number 2022-256, a contract with Renaud & DeAppolonio, LLC, Cranford, NJ in the matter entitled Beverley Figueroa v. UC, et al, to reflect an increase in an amount not to exceed \$15,000.00 for a total contract amount not to exceed \$30,000.00. (Chair Rebecca Lynne Williams)

OFFICE OF THE COUNTY MANAGER

Edward Oatman, County Manager

1. Authorizing the County Manager to apply for and obtain a grant in an amount of \$250,000.00 from the New Jersey Department of Community Affairs to carry out a project to rehabilitate the Clark Reservoir. (Chair Rebecca Lynne Williams)

Commissioner Mirabella noted that he was happy to see this item on the agenda, recognizing the efforts of NJ Senate President Nicholas Scutari and County Manager Oatman to this end.

County Manager Oatman advised that he continued to work closely with the State relative to the rehabilitation of the Clark Reservoir.

2. Authorizing the County Manger to enter into a contract with Mast Construction Services, Inc., Little Falls, NJ for Construction Management and Owner's Representative Services related to remedial work at the Ash Brook Golf Course Clubhouse in an amount not to exceed \$188,000.00. (Chair Rebecca Lynne Williams)
